



Notice of Underground CCTV Surveys - Aston Church Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

CCTV Surveys

We will be carrying out a series of CCTV drainage surveys in locations along Aston Church Road. These will take place from Monday 31 October to Friday 3 November. Dates are subject to the progress of the surveys programme.

Drainage inspections are non-intrusive surveys and help us plan which utility diversions need to be carried out. During these surveys, an operative will lift the manhole cover, use a sewer camera to examine the underground pipes and then replace the cover.

Road closure

To be able to carry out these surveys safely and effectively, we will need to put in place temporary traffic lights on a section of Aston Church Road along with a road closure and a diversion route on a section of Arley Road. These will be in place from 9.30am to 3.30pm each day.

Access to properties and businesses will be maintained at all times via a clearly marked diversion route.

We may also be on site up to one hour before and one hour after this for site set up and shut down.

Clear diversion routes.

Low levels of construction noise and vibrations as we excavate.

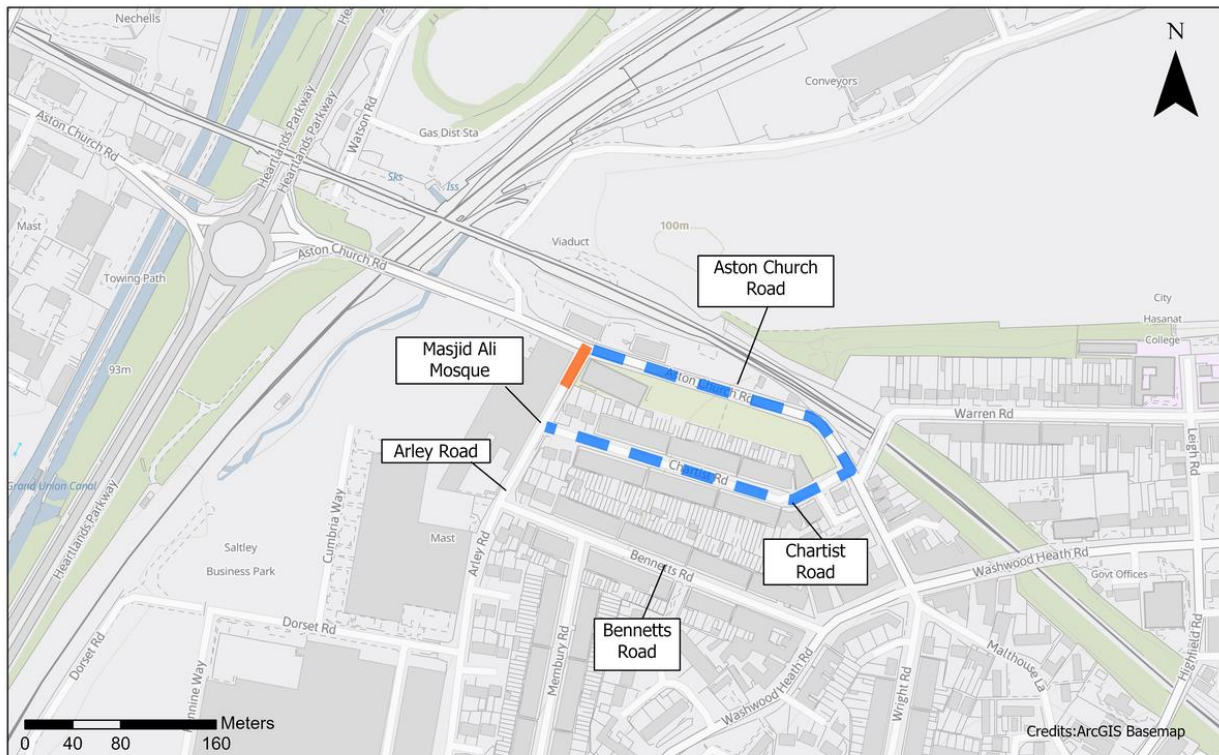
