High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be carrying out several utility surveys on and around the carriageway of Church Lane, Middleton. To complete the surveys a team of engineers will visit the location and record what is present in the area. They will carry out trial trenching, which will involve digging into the ground to establish what is underneath the surface. This will provide us with information which we need to assess as we develop our construction plans.

When these works will take place

These works will take place from **Monday 3 October to Friday 7 October from 9.30 am to 3.30 pm**. To complete these works safely we will be implementing a full closure of Church Lane during these times. A fully signed diversion will be in place (Please see map on page 2)

These surveys will take place from Monday 3 October to Friday 7 October 2022.

Our working hours will be 9.30 am to 3.30 pm.

Our workforce may be on site one hour before and after to set up and take down our work equipment.

What to expect

Traffic management on local roads while we complete these works.

We will install signage on the roadside.

Some low level noise will be generated from the work we are completing.

What we will do

Inform you in advance of any changes to the date(s) shown.

Keep all sites safe and secure.

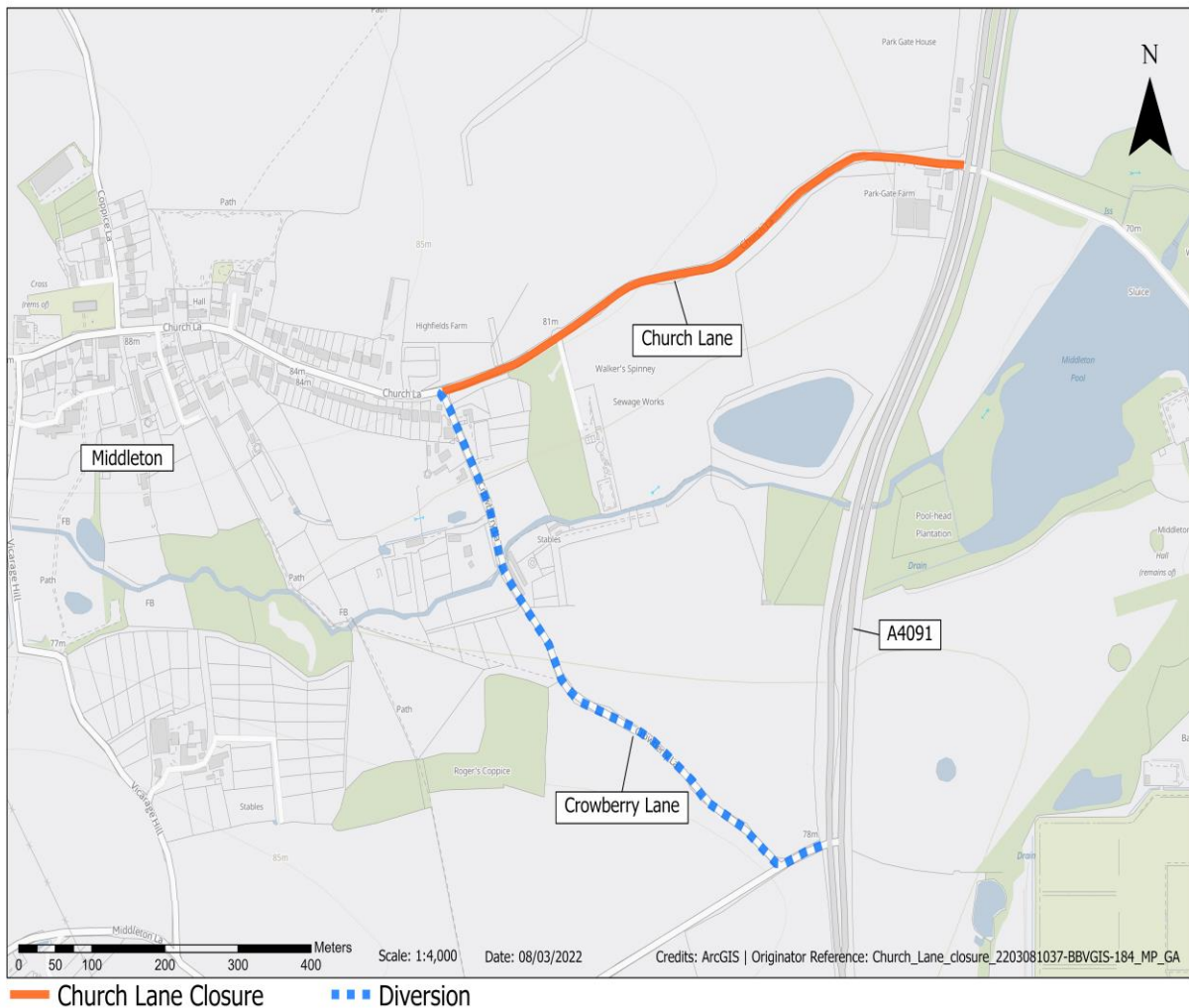
