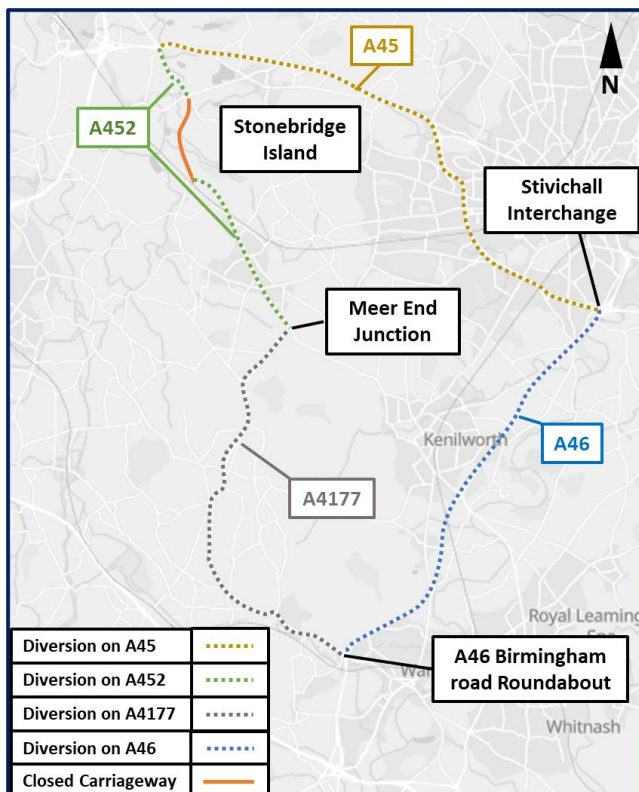
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

## The work we will be doing

Whilst carrying out our construction activities on the A452 we have identified that the existing safety barrier has become unstable. To protect all road users, we plan to install a temporary safety barrier on the northbound carriageway between Aston Martin Roundabout and Meriden Road Roundabout. To do this safely we will need to close the northbound carriageway overnight. Northbound traffic will be diverted south via the B4177 to the A46, then back up the A45 to Stonebridge Island. Southbound traffic will be unaffected. (See map Below).

## When will these works take place?

The northbound carriageway will be closed for emergency work from 10pm on Monday 5 September to 6am on Tuesday 6 September and again from 10pm on Friday 23 September to 6am on Saturday 24 September



## Duration of works

10pm on Monday 5 September until 6am on Tuesday 6am September

Then again at 10pm on Friday 23 September until 6am on Saturday 24 September
