High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

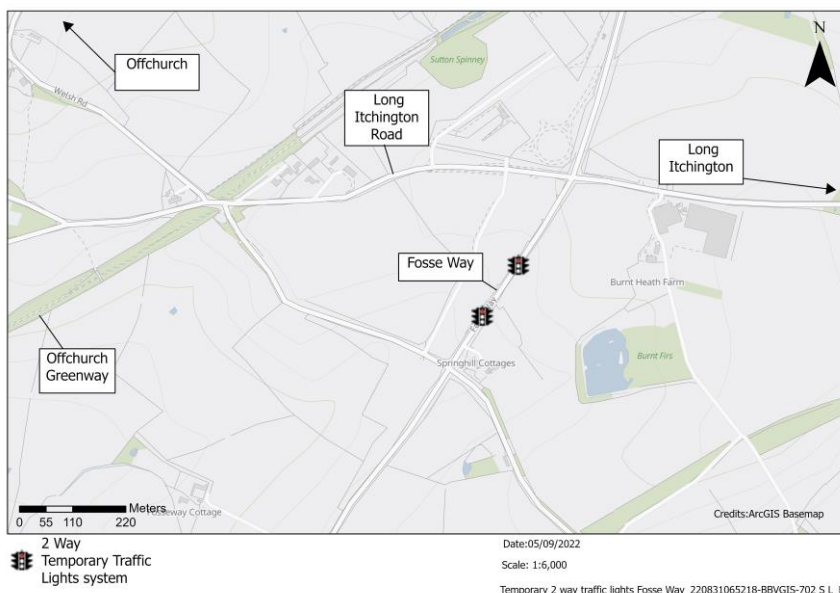
We will be constructing a plant crossing between the roundabouts, at the junctions of Welsh Road and Long Itchington Road.

We will need to install two-way temporary traffic lights, to ensure a safe working area while we install the plant crossing. These will be removed once the works are complete.

The plant crossing will remain in place until 2024 to allow construction traffic movement without impacting public journey times and traffic volume to the area. This will be done by installing traffic lights at the crossing to ensure public traffic always has priority.

When will these works be taking place?

Monday 10 October to Friday 21 October 2022 temporary traffic lights will be in operation 24 hours per day. Our working hours will be 8am to 6pm Monday to Friday and possibly 8am to 1pm on Saturday.

Duration of works

Monday 10 October 2022 to Friday 21 October 2022.

Temporary traffic lights will be in operation 24 hours a day on these dates.

There will be minimum disruption to your journey time.

Our working hours will be **8am to 6pm** Monday to Friday. Saturday working may be necessary between **8am and 1pm**.

Our workforce may be on site one hour before and one hour after, to set up and secure our equipment.
