

## Notice of utility works preparation off Tolldish Lane, Great Haywood

High Speed Two (HS2) is the new high speed railway for Britain. To allow for the construction of the new railway and to continue to ensure a safe and reliable gas supply, Cadent is moving an underground gas pipeline on land either side of Tolldish Lane, Great Haywood.

Main work to move the pipeline is planned to start in March 2023 and Cadent expects that all work will be completed by October 2023.

### What are we doing?

Before the main work to move the pipeline starts, Cadent will carry out some preparation activities from early-October until early-November 2022.

The work will involve:

- Setting up a small temporary works compound on the southern side of Tolldish Lane.
- Digging archaeological trenches on land either side of Tolldish Lane.

All vehicles will access the working area and temporary compound from Tolldish Lane, via A51.

### How will this affect you?

All work will take place within standard HS2 working hours and will be undertaken using standard industry methods. There may be some noise during the work, we do not expect this to cause any disruption.

### COVID-19

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

- Early-October 2022 until early-November 2022
- Working hours will be 8am to 6pm (Mon-Fri)
- We will be on-site one hour either side of these times for set-up and close-down

- Work taking place on land off Tolldish Lane, Great Haywood
- Vehicles accessing the area via the A51
- Signage at the roadside to ensure safe access and exit
- Security on site and no lodging

### What we will do

- Make sure all construction vehicles use agreed routes
- Maintain a safe working environment
- Inform people in advance of any changes
