### Notice of utility works preparation near Hanyards Lane, east of Stafford

High Speed Two (HS2) is the new high speed railway for Britain. To allow for the construction of the new railway and to continue to ensure a safe and reliable gas supply, Cadent is moving an underground gas pipeline near Brancote, east of Stafford. Main works to move the pipeline is planned to start in March 2023 and Cadent expects all work will be completed by October 2023.

### What are we doing?

Before the main work to move the pipeline starts, Cadent will carry out some preparation activities from early-October until mid-December 2022.

The work will involve:

- Setting up a temporary works compound off the other off Hanyards Lane (see map overleaf). There will be no on-site lodging.
- Vegetation clearance. Cadent will carry out appropriate ecological surveys before any vegetation clearance. Cadent's ecologist will be present throughout the activity to ensure there is no disruption to birds and local wildlife.
- Digging small pits to identify the utility services in the land we'll be working in.
- Digging archaeological trenches on land south of Hanyards Lane.

Vehicles will access the working area from Hanyards Lane, via Tixall Road.

### How will this affect you?

All work will take place within standard HS2 Ltd.'s working hours using standard industry methods. There may be some noise during the work, we do not expect this to cause any disruption.

### COVID-19

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

### What we will do


- Make sure all construction vehicles use agreed routes
