




Notice of road closure, Keepers Lane, Little Missenden

This notice is to inform you of a temporary road closure and diversion on Keepers Lane, Little Missenden, to carry out some instrumentation and monitoring (I&M) surveys.

What will we be doing?

A small team will enter the site boundary via the farm gate on Keepers Lane and lay approx. 170 meters of track matting. A branch and tree stump will be removed for access. Heras fencing will be erected around the small surveying area at the end of the track where a drilling rig will be used to assist with the surveys. Once the rig is mobilised, the surveying area will be accessed intermittently, and the road re-opened in full.

Why are we doing these works?

Prior to any infrastructure works, various surveys are carried out across a broad area. The readings provide accuracy of elevation from one site location to another that is then cross referenced against the design. Surveys were conducted here during the summer of 2021 and January of 2022 and are being repeated to ensure accuracy. Standard practice used by engineers and surveyors.

Will there be any noise impact?

You may hear the track matting being laid, the rig being delivered, mobilised, and as it operates.

Duration of works

Thursday 29 September to Friday 4 November from 10am to 3pm

What to expect

- Part road closure on the southern end of Keepers Lane in both directions
- A signed diversion in place, via Chesham Road and Hyde Heath Road
- Operatives visibly working in the area

What we will do

The closure will be in place between 10am and 3pm, avoiding peak times

We will reopen the road as soon as we are able to

How will these works affect you?

From the A413 to the railway bridge, Keepers Lane will be closed to traffic, including cyclists, in both directions. A fully signed diversion will be in place via the nearest B-road which is Chesham Road leading onto Hyde Heath Road and Weedon Hill. The closure details are:

- 29 September 2022 to 4 November 2022
- From 10am to 3pm


We aim to meet our planned working dates, but these can change due to the impact of the weather or programme changes. We will do all we can to keep you updated.

The road closure and diversion will not come into effect until 10am and will end at 3pm after which, the road will be reopened, and the diversion removed.
