

# Temporary traffic lights Fosse Way, Offchurch



High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

### **Temporary traffic lights and lane closures**

LM needs to install temporary traffic lights with lane closures around the Fosse Way/Welsh Road roundabout and Long Itchington Road/Fosse Way roundabout from Monday 19 to Friday 23 September between 9:30am and 3:30pm (see map below). The reason for the temporary traffic lights is to create a safe working zone when carrying out works. The location of the temporary lights will also change depending on where works are required.

This timeframe is subject to consents so please do check on the road signs – any changes will be published on the **hs2inwarwickshire** website. For live traffic information please go-to **one.network**.

#### **Duration of works**

19 September until 23 September 2022

Temporary lights erected where required between 9:30am and 3:30pm

We may be on site for up to one hour before or after those times, to set up or pack up
