
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

Subject to consent, we will be completing works to install reptile fencing adjacent to the M42, near Coleshill. In order to complete these works safely, we will install a temporary southbound hard shoulder closure on the M42.

The southbound hard shoulder closure will be in place from **Monday 26 September until Friday 7 October from the hours of 9.30am until 3.30pm**. There will be no weekend traffic management as part of these works. **The location of this traffic management is outlined on the map below.**

Our workforce may be on site one hour before and one hour after, to set up and take down equipment.



Duration of works

- Traffic management to be in place along the M42 from Monday 26 September until Friday 7 October
