High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

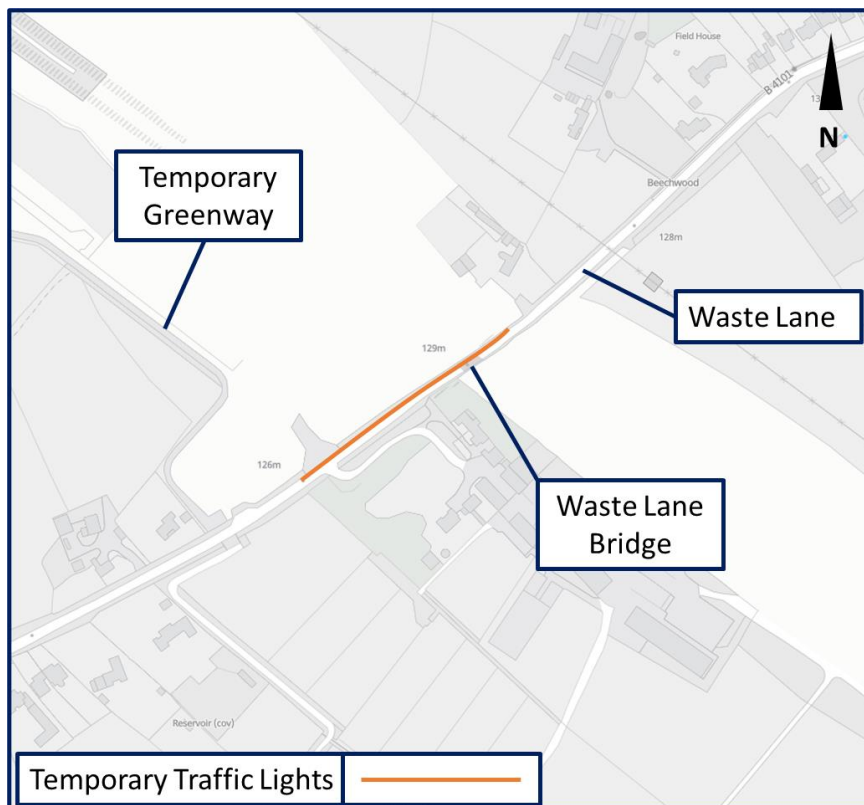
### The work we will be doing

BBV will be undertaking some survey works near to the bridge on Waste Lane. This will also include strimming back some vegetation in the areas that are being surveyed. To do this safely we will need to install temporary 2 way traffic lights on Waste Lane.

### When will these works take place

The works will take place on Monday 10 October and Tuesday 11 October and will be in place from 9:30 am until 3:30pm
