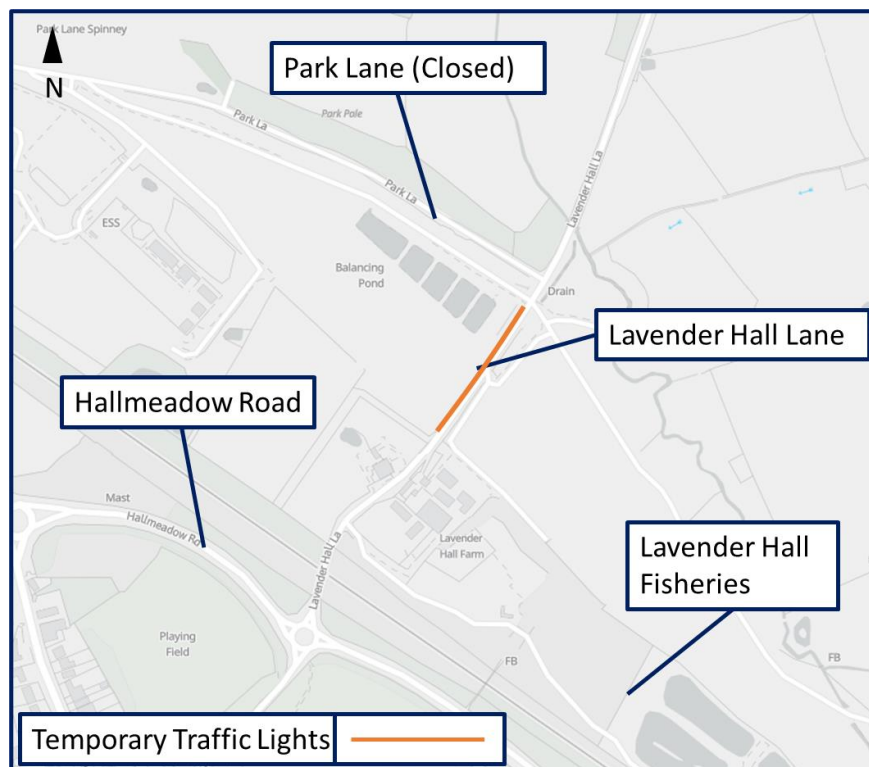
The work we will be doing

The new railway will pass under a new bridge on Lavender Hall Lane. In order to divert utilities around this area we will need to remove the vegetation on either side of the road. To remove this vegetation safely we will need to install temporary traffic light in this area.

When will these works take place

The lights will be in place from Monday 3 October until Friday 7 October and will be in operation from 8am until 6pm

Monday 3 October until Friday 7 October and will be operation 8am until 6pm

Low level of noise from our works between 8am and 6pm
