
#### The work we will be doing

BBV will be installing new parking bays and a footpath into the existing grass verge on the southbound side of Hallmedow Road. To do this safely we will need to close the southbound lane opposite the junction with Riddings Hill. Access will be maintained throughout using threeway traffic lights placed either end of the closure and on Riddings Hill.

#### When will the work take place?

The lights will be in operation from 8am Monday 19 September to 6pm Friday 14 October, 24 hours a day seven days a week. Our normal working hours will be 8am until 6pm Monday to Friday.
