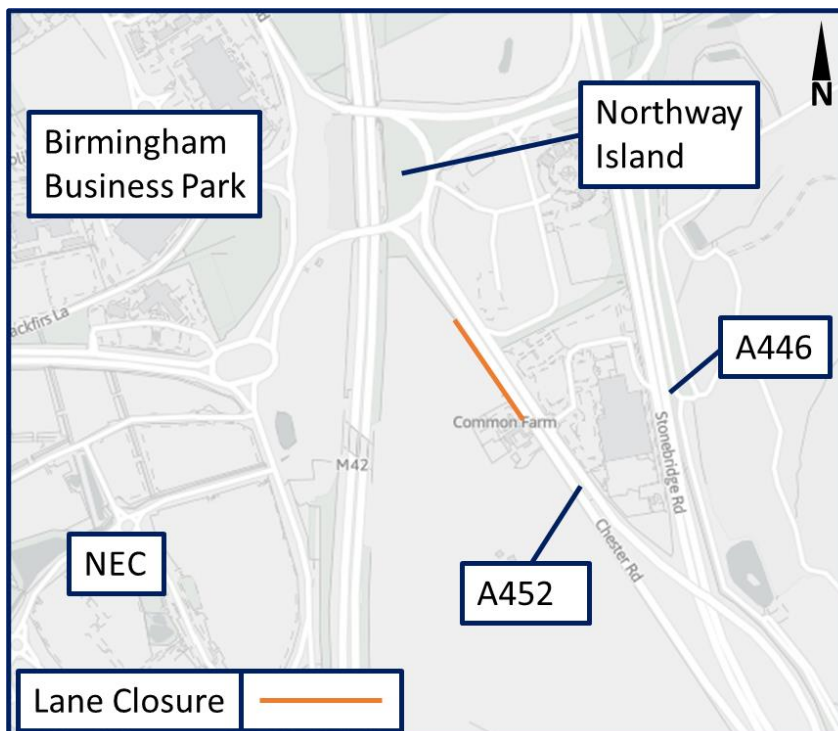
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

The work we will be doing.

To build the new railway, the A452 Chester Road between the A446 and the Northway Island is being significantly remodelled. The next phase of this work will require a lane two closure from Northway Island heading southbound past Melbicks Garden Centre, this is to allow safe working room for the construction of another leg to the new roundabout. The A452 northbound traffic from Stonebridge Island will be directed around the new roundabout for Birmingham Business Park and Chelmesley Wood.

When will these works happen?

These works will start on Friday 16 September and continue throughout Autumn.
