High Speed Two (HS2) is the new high speed railway for Britain. As we reintroduce face to face engagement, we will continue to follow government guidance on reducing the spread of Covid-19. The health and safety of our workforce and the communities we work within is our priority. What are we doing?

We will be conducting mobile surveys in Hyde Heath Road / Weedon Hill and the top of Chesham Road for one day. These are in relation to the construction of the Chiltern Tunnel. You may see operatives along Hyde Heath Lane, Weedon Hill and Chesham Road with monitoring equipment.

Why are we doing these works?

We are carrying out Instrument and Monitoring (I&M) surveys before, during, and after our tunnelling and infrastructure construction works for the Chiltern Tunnel. These surveys are intended to record, measure and monitor the construction of the tunnel.

How will this affect me?

As the team need to survey close to the roadside, they need to be protected from vehicles by using traffic management. This will be directed with mobile stop and go boards operated by traffic marshals who will move along Heath Lane, Weedon Hill, and Chesham Road in sections on 20 September from 9am to 3pm:

Avoiding peak times

The use of stop and go boards will be implemented from 9am to 3pm only to minimise disruption to peak traffic. The team may be visible before this time to receive their briefing and prepare to survey. A map can be found on page 2.

What to expect

Traffic will be managed using stop and go boards between Frith Hill and Weedon Hill

Surveyors will be working close to the roadside or in a work area in the carriageway

What we will do

Maintain traffic flows wherever possible and reducing waiting times for traffic in both directions along Frith Hill, Hyde Heath Road, and Weedon Hill.

Keep the traffic flowing and fully reopen the road as soon as possible

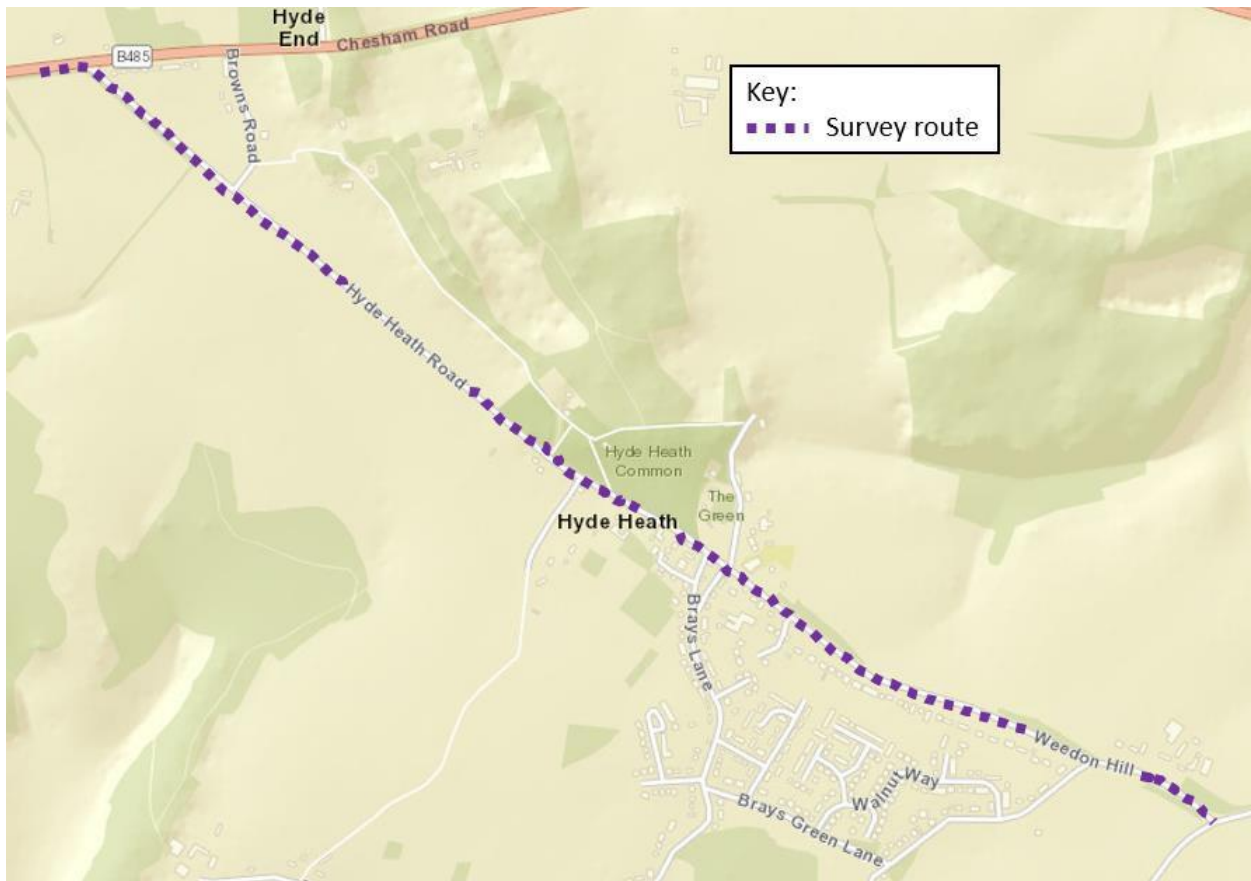
