Update: Park Village East utility works

High Speed Two (HS2) is the new high speed railway for Britain.

Parking bays suspended on Park Village East - 20 September

We previously informed you, we need carry out works to strengthen and protect the utilities beneath Park Village East ahead of tunnelling and major excavation works within our Camden Cutting worksite.

We will access the sewer for these works via existing manholes within the carriageway on Park Village East.

On 20 September, we will suspend two parking bays on Park Village East just south of Mornington Street bridge to access the manhole for CCTV surveys. The survey will take about an hour and we will reopen the parking bay once we have finished.

We planned to line the sewer at the northern end of Park Village East in mid-September but have now postponed these works until mid-October. We will update you once we have confirmed the date and traffic arrangement for the sewer lining.
