### Notice of works to the South of Euston Station

High Speed Two (HS2) is the new high speed railway for Britain.

## **Update on Gordon Street, Gower Place and Endsleigh Garden sewer surveys**

We wrote to you in March 2022 (HS2-MW-MD-Ph1-Eu-St-S3-Site-11-28/01/2022) to let you know that a number of enabling works will be carried out in the local area as part of the HS2 Euston Station works. This notification provides a further update on sewer surveys taking place in **August 2022 until Mid -September 2022.** 

### Vodafone works on Torrington Place, Byng Place and Malet Street

**From Mid- September until late October 2022**, BRM Utility Services Ltd are working on behalf of Vodafone to undertake fibre optic installation and diversion works at Gower Place, Torrington Place and Malet Street.

#### **Working hours:**

- 8am to 6pm weekdays (excluding bank holidays)
- Weekends 8am to 6pm
- Gordon Street, Gower Place and Endsleigh Gardens surveys and BT works will take place at night (9pm to 5am)
- We will start-up and close-down activities up to one hour before and up to one hour after normal working hours above

#### What to expect:

- Alterations to public walkways;
- Partial road closures;


- Create temporary work sites and signage where surveys and investigations are taking place;
- Please note that changes to the programme may occur, and if these changes are likely to cause any disturbance, we will write to you again

## Gordon Street, Gower Place and Endsleigh Gardens sewer surveys until mid-September 2022

We are currently undertaking condition and connectivity investigations to the sewer on Gordon Street, Gower Place and Endsleigh Gardens. To facilitate these works we insert a camera into manholes and take photographs of the sewer. The surveys will help us determine the locations of the sewers and how to connect them at a later stage.

We will carry out the survey at night when there are fewer pedestrians. To enable the works, we will temporarily close sections of Gordon Street and Gower Place and install temporary traffic lights to help keep the flow of traffic. Access will be maintained and work sites will be cleared and reinstated daily. This work is not expected to be noisy.



#### What to expect

We will closely monitor all noise, vibration, and dust levels to ensure we do not exceed our agreed limits. These works will not affect utility connections in the areas. Please note that changes to the programme may occur, and if these changes are likely to cause any disturbance, we will write to you again.

#### Works will include:


- Temporary alterations to public walkways
- Two sections of Endsleigh Street where bays will be suspended. One section of 4 bays and another of 2 bays
- Closure of a section of the road on Gordon Street and Gower Place during works, work sites will be cleared and reinstated daily
- We will work to minimise disruption wherever possible

#### **Working hours**

- Between 9pm to 5am weekdays excluding bank holiday and
- We will start-up and close-down activities up to one hour before and up to one hour after normal working hours above

## Vodafone works on Torrington Place, Byng Place and Malet Street from Mid-September until late October 2022

To enable the fibre optic installation and diversion works we will temporarily close Torrington Place, Byng Place and Malet Street as shown below for approximately 3 weeks. Parking bays in the area adjacent to the works will be suspended. Pedestrian access will be maintained using a temporary crossing throughout. Traffic diversions will be in place; northbound via Montague Place, Grafton Way and Euston Road, and southbound via Keppel Street.



#### What to expect

We will closely monitor all noise, vibration, and dust levels to ensure we do not exceed our agreed limits. These works will not affect utility connections in the areas. Please note that changes to the programme may occur, and if these changes are likely to cause any disturbance, we will write to you again.

#### Works will include:

- Temporary work sites
- Full road closure
- Suspension of several bays on Malet Street and
- delivery and removal of materials to and from site

#### **Working hours**

- 8am to 6pm weekdays (excluding bank holidays)
- 8am to 6pm Saturdays
- We will start-up and close-down activities up to one hour before and up to one hour after normal working hours above

# Gordon Street BT Openreach works - at the junction of Endsleigh Gardens and Gower Place - September 2022

In addition to the above works, during September BT Openreach will also be working in the area. They will be installing new cables and jointing these cables to the existing network. These works will take place at night and will not involve noisy working. There will be no excavation. All works will take place via existing BT chambers and manholes. Lane closures will be in place at these locations with traffic still able to access these roads. There will be no disruption to existing supplies during these works.
