High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

We wrote to you in June to tell you about the works we are doing to excavate the ventilation shaft at our South Ruislip site.

These works are ongoing and will continue from 20 September to 21 October 2022. We will be digging the main shaft to 36 metres below ground level.

We will use an excavator, tipper trucks and a crane to carry out these works.

How the work might affect you

We will have an increase in lorry movements to remove the muck from site.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.
