## What we are doing

We wrote to you in April to let you know that we would be carrying out overnight utility surveys on Old Dairy Lane.

We have completed these surveys, however we need to undertake further surveys overnight from 20 to 22 September 2022. We will use CCTV cameras and scanning equipment to carry out the surveys in the area shown on the map overleaf.

## How these surveys might affect you

Temporary traffic management and safety zones will be in place to ensure the surveys can be carried out safely.

We would like to apologise in advance for the disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.

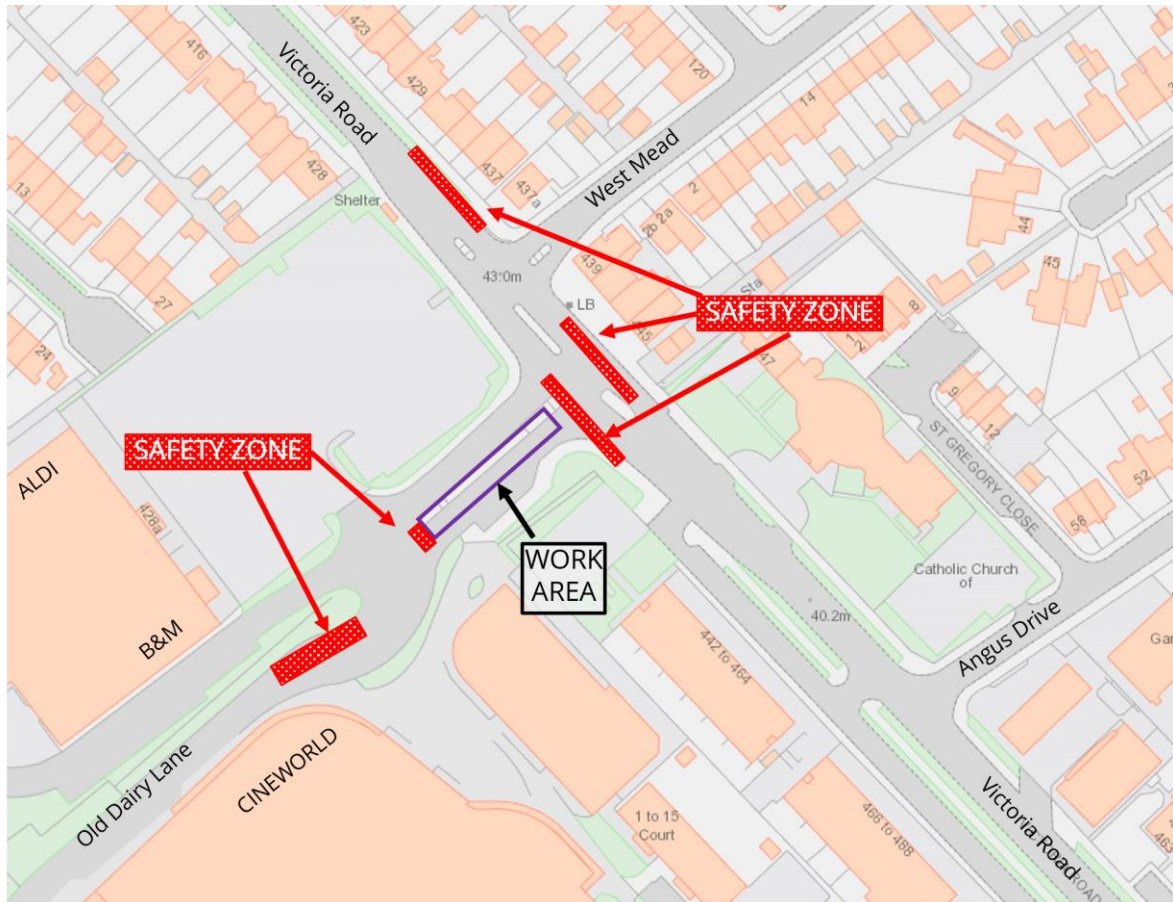
