
High Speed Two (HS2) is the new high-speed railway for Britain. Initial works have now started and are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.



Planting is required to fully complete the new roundabout scheme at Park Lane along the A452, Berkswell this autumn. To carry out these works safely, LM will need to install temporary lane closures along the A452 from 2nd November 2022 to end of January 2023 between 9:30am and 3:30pm on north and south bound carriageways. (see map below).

Please note that the location of the temporary lane closures will change depending on where works are required. Please check signage on the road as dates may change. All work is subject to consent, site and weather conditions.

Local diversions will be clearly signposted. Access for residents and businesses will be maintained. **For live up-to-date traffic information and diversion routes please go to one.network.** Any changes will be published on the **hs2insolihull** website.

2nd November 2022 to end of January 2023

Working hours

Daytime working hours Mon to Fri 8am to 6pm

Our contractors may also be on site for up to one hour beforehand and after to set up and pack up the site.
