High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

#### The work we will be doing

The new railway will pass over Colehill Heath Road and past Heath Park on an elevated retained wall structure. This will require several utilities such as electricity and telephone cables to be diverted so that our works do not interfere with the supply. We will be digging new trenches, laying new pipes and cables. To do this safely we will close Colehill Heath Road over night for a period of Six weeks.

#### When these works will take place

The works will happen overnight from Monday 14 November until Thursday 22 December. We will close the road between 8pm and 6am Monday to Friday. Depending on the progress made and to minimise any disruption the closures times and end date may vary.

All works are subject to weather conditions, we will keep you up to date with any changes at www.hs2insolihull.co.uk.


