High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

# The work we will be doing

To facilitate final design for permanent works, we will be undertaking surveys on Crackley Lane, Kenilworth.

To carry out this work safely we will be closing sections of Crackley Lane. The work will be carried out in three days. Each day will involve work on a different section of Crackley Lane, with two diversion routes in place.

## When will these works be taking place?

Crackley Lane will be closed **from 14 November 2022 to 16 November 2022** between the hours of **9.30am and 3.30pm** to minimise disruption to peak traffic. Full diversions will be in place (please see maps below).

### Access will be maintained to all properties.

Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.
