The work we will doing

We are working with National Highways to complete emergency surfacing works on the A38 southbound carriageway at Streethay. These works are required, to repair and resurface a section of the highway, to ensure the safety of road users.

When the work will take place

The A38 southbound carriageway will be closed from 9:00pm on Tuesday 18 October and will re-open at 5:30am on Wednesday 19 October.

Where we will be working

The map below details the A38 southbound diversion route.

Southbound diversion: traffic will be diverted from Hilliard's Cross, along Wood End Lane, A515 Tewnals Lane, A51 Stafford Road, A5192 Eastern Avenue and onto Cappers Lane.
