



Notice to extend traffic management on Watling Street, Lichfield

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The works we will be doing

We will be undertaking works to install a signalised junction/ crossing, on the north and south side of Watling Street, to allow our vehicles to safely access our working area.

When the works will take place

We commenced works on Monday 7 November 2022 which were due to be completed on Friday 25 November 2022. Due to poor weather conditions last week, we will extend the works, which will now be completed on Wednesday 30 November 2022. To carry out our works safely, we will have temporary traffic lights on Watling Street over this period. The traffic lights will be in place 24 hours a day until our work is complete.

Our working hours will be between 8am and 6pm. Our workforce may be on-site up to one hour before and after to set up and secure our equipment.

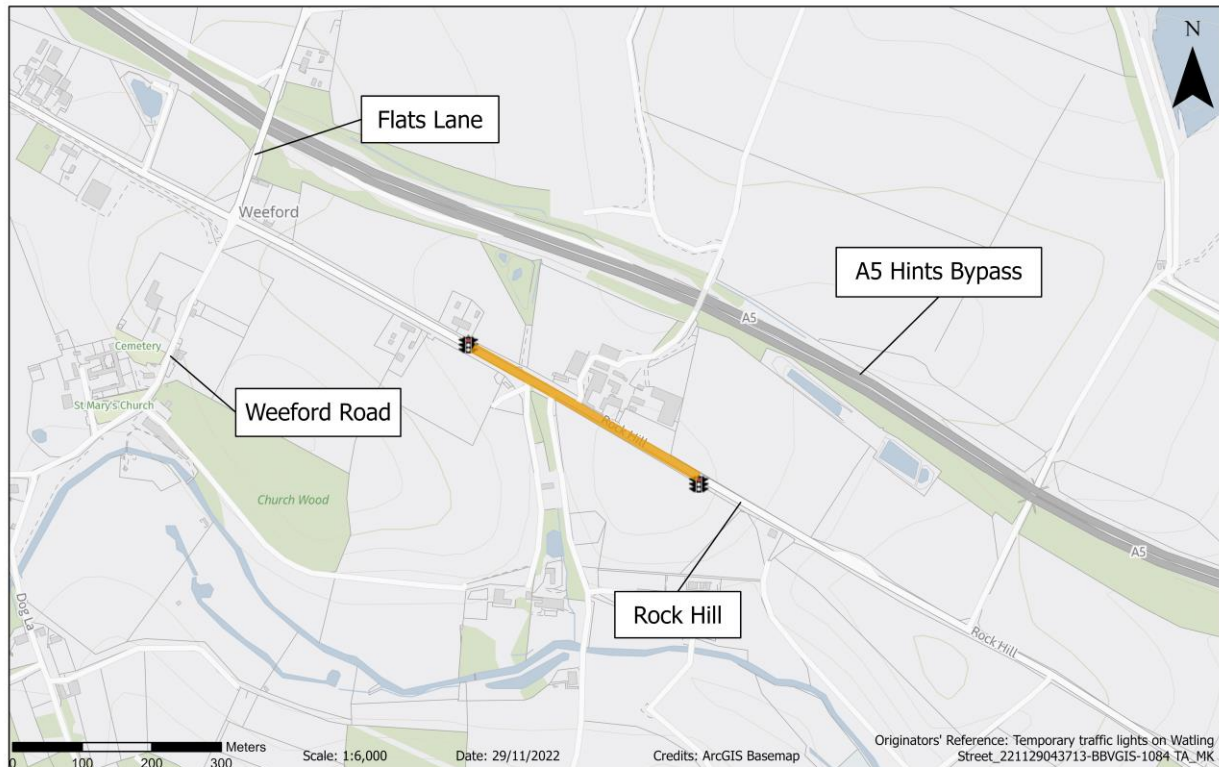
