High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

We will be carrying out drainage surveys, to support the design process.

We will need to install two-way temporary traffic lights, to ensure a safe working area while we carry out the surveys. These will be removed once the works are complete.

### When will these works be taking place?

**Tuesday 25 October to Tuesday 25 October 2022** temporary traffic lights will be in operation for the duration of the works. **Our working hours will be 9.30am to 3.30pm** to minimise disruption to journey times
