High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Utility diversions

Ahead of constructing the new HS2 structures on Duddeston Mill Road we will need to carry out some work on a gas pipe which currently passes through our construction work area. To carry out this work we will need to excavate a small section of road on the junction of Duddeston Mill Road and Network Park Industrial Estate, we will then pour concrete into the hole to grout the gas pipe.

Temporary traffic lights

To be able to do this work safely we will need to put in place three-way temporary traffic lights from Monday 7 November until Friday 11 November on the junction of Duddeston Mill Road and Network Park Industrial Estate. The temporary lights will be manually operated during peak travel times to help to reduce congestion. Access to properties and businesses will be maintained throughout.

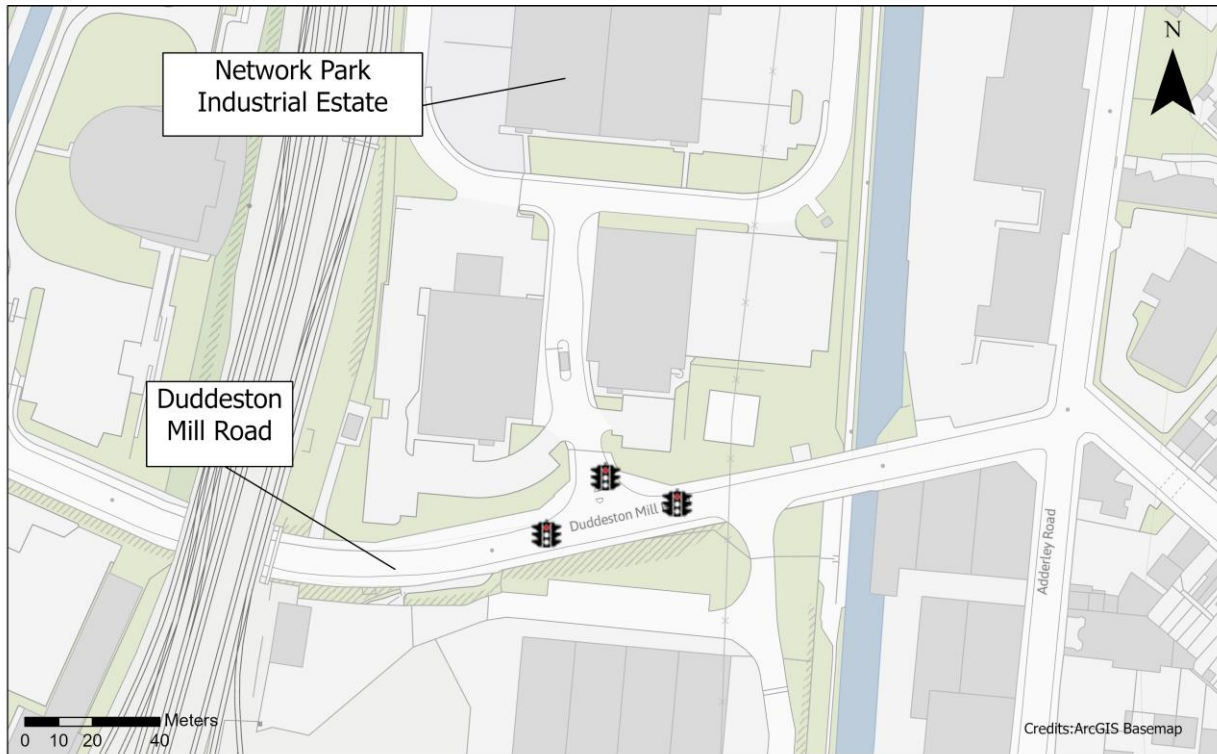
