## Notice of traffic management on A4091 / Bodymoor Heath Lane

**Notification** 

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

#### The work we will be doing

We will be diverting utilities, located alongside and across A4091, that will require us to work on the carriageway. Once we have diverted the utilities, we will cover them with a protective slab to ensure they are safely secured. To allow us to complete these works safely we will require a temporary lane closure on a section of A4091 with temporary traffic lights (see map on page2). We will also have a full closure of Brick Kiln Lane to undertake survey works ahead of the utility diversion.

#### When these works will take place

These works will take place from 7 November to 23 December 2022. During this period, we will have a single lane closure with temporary traffic lights in place on the A4091. The temporary traffic lights will be in place for 24 hours per day until completion of the works.

From 7 November to 8 November 2022, we will have a road closure on Brick Kiln Lane between 8.00am until 6.00pm each day. During this period access will be maintained for residents.

Inform you in advance of any changes to the date(s) shown.


