High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Upcoming utility surveys

We will be carrying out overnight utility trial hole surveys on High Street from Monday 14 November until Friday 18 November. These surveys will help us to plan where utility diversions will be required as we prepare to construct the railway in Birmingham.

To complete the utility trial hole inspections, we will use a vacuum excavator, which uses compressed air to loosen or agitate the ground. The loosened material is then removed using the vacuum on the machine creating a hole. At times we will also use hand digging tools to excavate the trial holes. Once the surveys are carried out, we will backfill and reinstate all the trial holes.

We do not expect this activity to cause high levels of noise or vibration.

Lane Closure

To be able to carry out these inspections safely and effectively, we will need to put in place a lane closure along a section of High Street. The closure will be in place between 9.00pm until 6.00am from Monday 14 November until Friday 18 November.

Access to properties and businesses will be maintained throughout.

Lane closure operational 9.00pm – 6.00am.

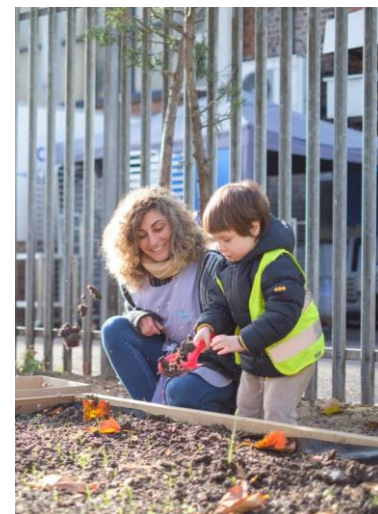
About our Community and Business Funds
