



# Notice of construction activities in Handsacre

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

We will be continuing works in the Handsacre area. This advanced works notification covers work from October 2022 to May 2023, including:

- Dismantling of Hanchwood House on Shaw Lane
- Constructing our haul roads
- Constructing our compound area at the junction of Shaw Lane and Tuppenhurst Lane
- Ground investigation surveys, to help us identify the location of buried utility services, such as gas, electric or water.

Haul roads are temporary roads within our working area that allows us to move materials and machinery and access our construction site effectively. Haul roads are used for construction traffic only and ensures minimal disruption to the local road network.

To complete our works, at this time, no traffic management is required. Upcoming work in this area may require traffic management and will have an impact on the local road networks. Once this work has been planned, we will send further updates.

## When the work will take place

The above works take place between October 2022 and May 2023. Works are. Our working hours will be 8am to 6pm. Our workforce can be on-site one hour before and after to set up and secure our equipment.
