



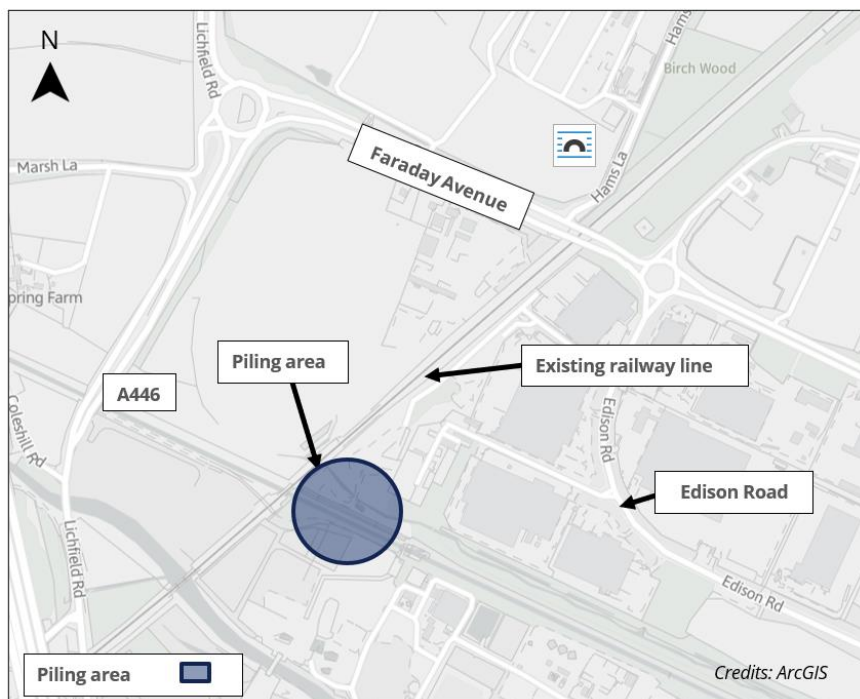
# Notice of extended working hours near Faraday Avenue – Saturday 15 October 2022

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## Extended working hours

To enable us to progress piling activity in your area, our working hours will be extended on Saturday, 15 October from 05.00am to 1pm. We have had consent approved for these working hours. Our contractors may be on site up to an hour before and after these times to set up and close down our sites.
