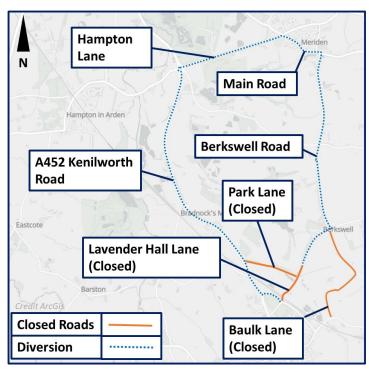
#### The work we are doing.

The new railway will cross over Lavender Hall Lane on a bridge. In order to prepare the area for this new structure we need to remove the existing vegetation. Our ecological surveys have shown that this area is suitable habitat for dormice. As such, it is important that this work is carried out now, before hibernation season. To do this work safely and before hibernation season we will need to close the road for a period of two weeks. Please note, for safety reasons, Baulk Lane will also be closed. Access for residents and business will be maintained on both roads

The road will be closed between 9:30am until 3:30pm Monday -Friday from Monday 24 October until Friday 4 November.
