High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

#### **Upcoming ground investigations**

From Monday 7 November we will be continuing to carry out ground investigation surveys along a section of Chester Road. These surveys will help us to locate third party utilities as well as investigate the ground conditions ahead of the launch of the tunnel boring machine.

The surveys will involve taking soil samples and excavating sections of the ground. To complete our survey works we will use a large excavator to expose the utility, we will then reinstate the area to the original condition.

Wednesday 9 November - Friday 25 November Working hours 8am -6pm Monday to Friday and 8am -1pm Saturday

Our workforce may be on site up to 1 hour before work begins to set up the site and again afterwards to take down our work equipment.

We will install temporary fencing to our work sites in the area where we are working.

Low levels of noise from work we are completing.

Ensure that our work areas are safe and secure.


