
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We previously notified that our demolition works to the Old Saltleians Rugby Club building near Gilson Road, was due to be completed by the end of December 2022. However, due to unforeseen circumstances these works will now continue until March 2023. The location of this work is shown in the map below.

As we carry out this work we will mobilise onto site, setting up welfare facilities and clearing the site. We will then carry out the soft stripping of fittings inside of the brick building, the demolition and removal of the brick building and the demolition and removal of the building foundations. We will need to move materials from the demolition off site.
