# Update: footway closure on Park Village East – 19 to 20 October

High Speed Two (HS2) is the new high speed railway for Britain.

## Footway closure for urgent site maintenance – 19 to 20 October

We need to repair site monitoring equipment behind our hoarding on Park Village East. This equipment can only be accessed from street-level.

From 19 to 20 October we will close a section of the footway at the southern end of Park Village East, while we remove a small section of the hoarding to access and repair the equipment. We expect these works to take about two days to complete. For safety, we will replace the hoarding and reopen the footway at the end of each day.

These works will not be noisy. We are sorry for any inconvenience caused.
