



Notice to extend closure of Rookery Lane, Hints

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

These works were due for completion on Friday 25 November, 2022. Due to poor weather conditions, which made large sections of Rookery Lane impassable and unsafe, we were unable to make necessary progress. We will now complete our works on Friday 2 December, subject to weather conditions.

We are constructing haul roads and accesses within Hints. Haul roads are temporary roads provided within a working area to allow for the movement of construction materials, construction machinery and/or construction staff around the site. Haul roads are Balfour Beatty VINCI's preferred logistical transport link, as they reduce the number of vehicle movements interfering with the existing local road network and provide the greatest possible control over works activity.

To allow our vehicles to cross Rookery Lane and to maintain the safety of road users, equestrian and pedestrians, we will create a signalised plant crossing. To enable us to commence these works we will require a temporary closure of a section of Rookery Lane.

When these works will take place

We will extend these works to Friday 2 December, 2022 which will require a closure of Rookery Lane to create a safe working area.

Pedestrian and equestrian access will **NOT** be maintained during this closure.

Our workforce may be on site one hour before and after to set up and take down our work equipment.

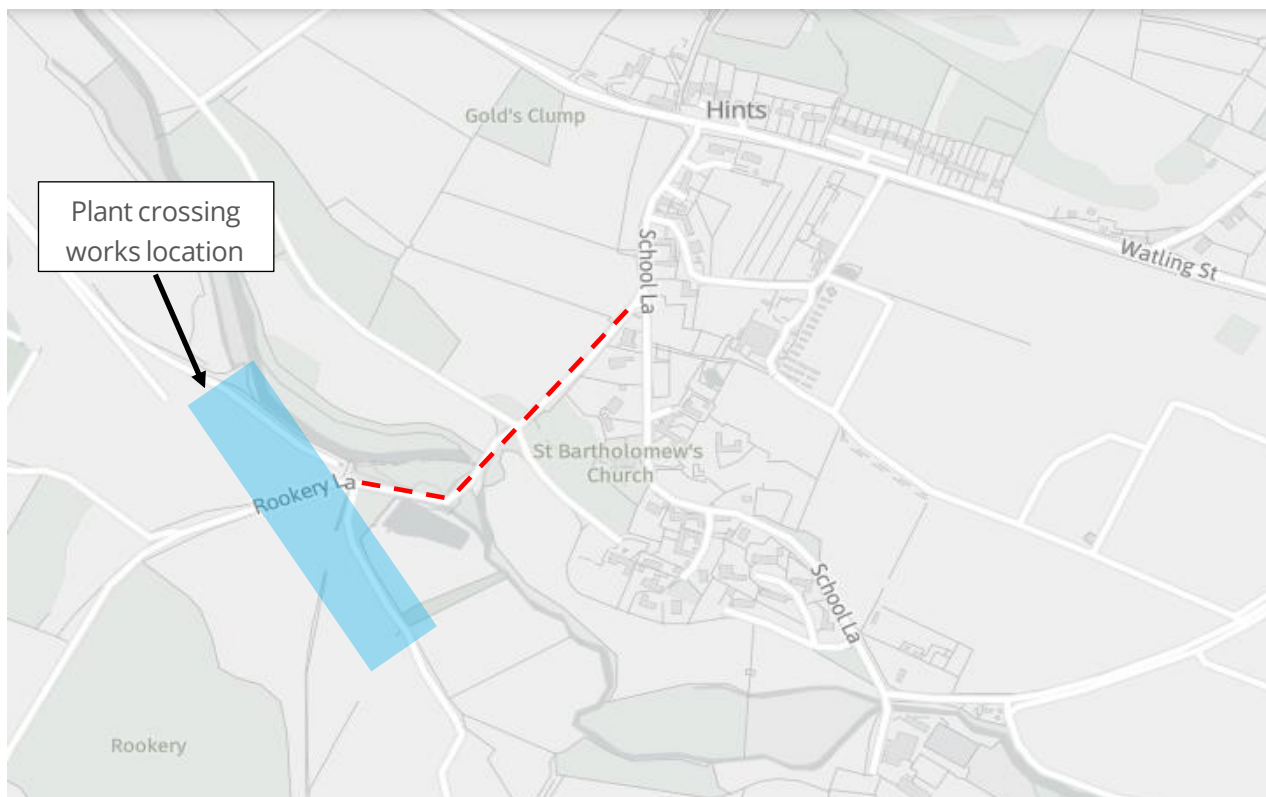
