High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To facilitate a plant crossing, we will be undertaking surveys on a section of Stareton Lane, Stoneleigh.

To ensure a safe working area while survey works are carried out, a section of Stareton Lane will be temporarily closed. The road will be reopened once the works are completed.

When will these works be taking place?

Stareton Lane will be closed on 31 October 2022 between 9.30am and **3.30pm** to minimise disruption to peak traffic. A full diversion will be in place (please see map below).

Access to all properties will be maintained.

Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.
