High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To complete pavement works and undertake surveys, we will need to undertake a lane closure across part of the entrance to Stoneleigh Park.

When will these works be taking place?

A lane closure of part of the Stoneleigh Park main entrance will be in place from **1 November 2022 to 3 November 2022**. The lane closure will be in place between the hours of **9pm and 6am**. Access to Stoneleigh Park will be maintained via the onsite security team.

Access to all properties and businesses on Stoneleigh Park will be maintained.

Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.
