

# Update: Utilities work on Adelaide Road

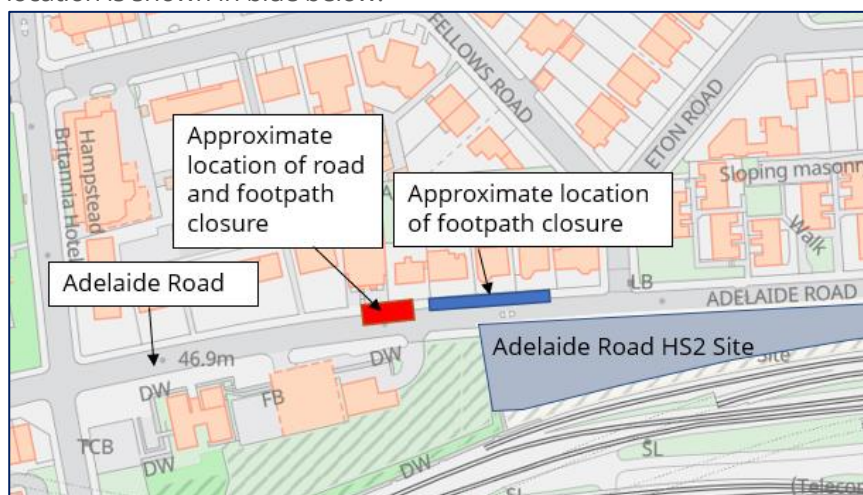

High Speed Two (HS2) is the new high speed railway for Britain.

## Ongoing utilities works

Utilities works are continuing on Adelaide Road until late November. From 24 October to 11 November 2022, there will be a lane and footpath closure opposite Modern Motors, outside 74-78 Adelaide Road. The location is shown in red on the map below.

The footway closure will extend in front of 70 – 74 Adelaide Road. The location is shown in blue below.



A pedestrian walkway will be created and maintained throughout the works.

## Ongoing vegetation clearance

Ongoing vegetation clearance works will be taking place close to the track side of our Adelaide Road Vent Shaft site. The work needs to take place over night when the trains are not running. We will be using handheld tools and lights to complete this work. We do not anticipate this work will cause disruption to residents.

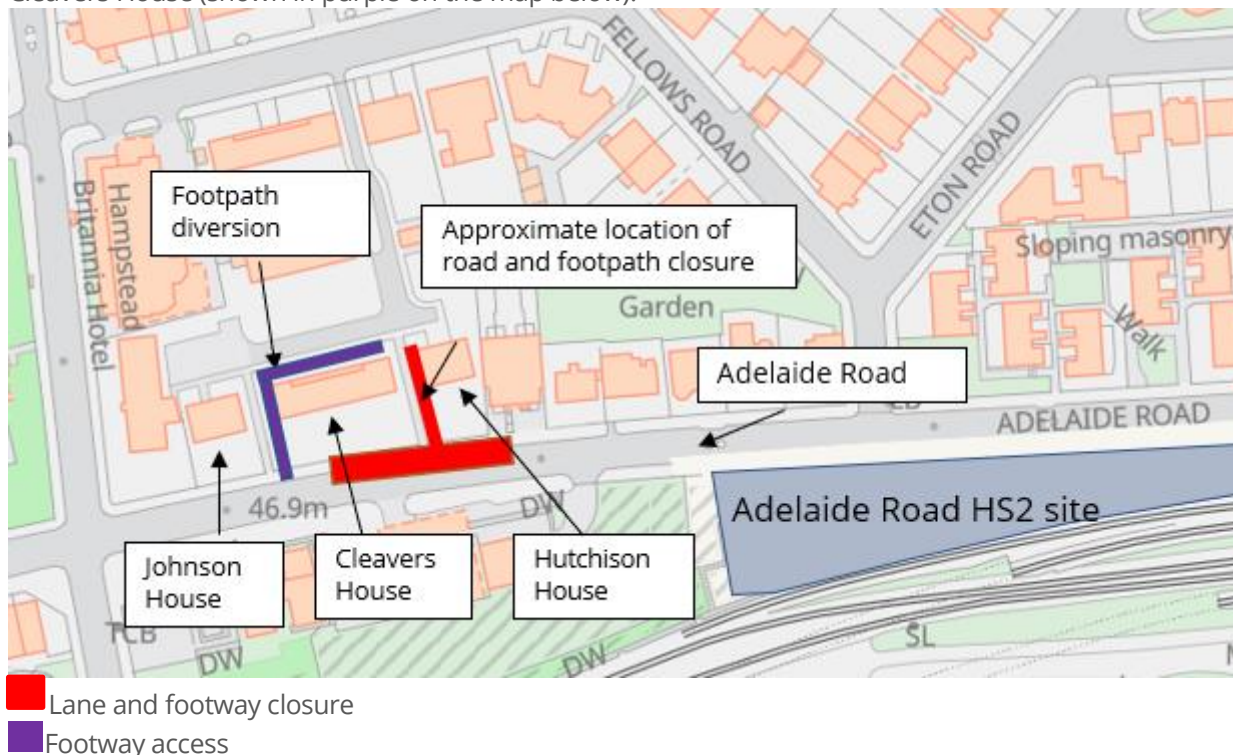

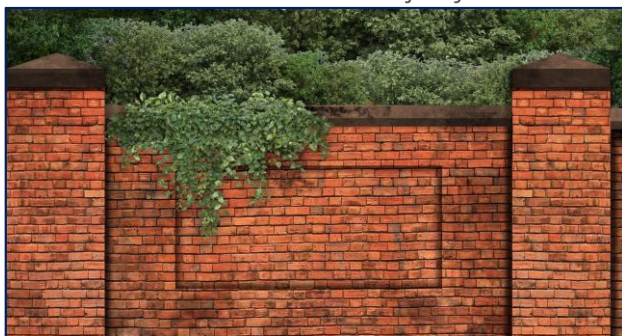
## Utilities works - footpath closure

We are currently undertaking utility works opposite Modern Motors and the Adelaide Road Medical Centre until 21 October 2022. Due to the works, there is a footway closure between Cleavers House and Hutchison House with pedestrians being diverted to the footway between Johnson House and Cleavers House (shown in purple on the map below).



## Hoarding

During late September and October, Skanska Costain STRABAG Joint Venture (SCSJV) will be installing the final hoardings on our Adelaide Road Vent Shaft site. We are planning to install artwork on the hoardings in November 2022. Further to engagement with the local community the brick work design shown below has received the majority vote.
