



# Updated notice of temporary traffic lights on Wood End Lane, Curborough

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 to build the new high-speed railway in your area.

## The work we will be doing

We will be undertaking preparation works along the verge of Wood End Lane. This includes the installation of signage, fencing and concrete pavement for our works access point. Temporary Heras fencing will be installed along the verge, located inside the construction site.

## When the work will take place

The works will take place from Monday 31 October to Friday 18 November 2022. To carry out our works safely, we will install temporary traffic lights on Wood End Lane for three weeks, as below:

- Monday 31 October to Friday 4 November, the traffic lights will be in place from 8am until 6pm.
- Monday 7 November to Friday 11 November, the traffic lights will be in place 24 hours a day.
- Monday 14 November to Friday 18 November, the traffic lights will be in place from 8am until 6pm.
