High Speed Two (HS2) is the new high speed railway for Britain.

Works planned on Kilburn High Road

From 21 November to 10 December 2022, we will be carrying out a series of ground investigation and CCTV surveys on Kilburn High Road outside the Marriott Hotel.

The ground investigations will consist of digging a temporary trench to confirm the location of utilities under the surface of the road. The investigations will help us to understand and aid the design of the new railway and the best ways to protect or divert any utilities during construction. Your utility services will not be affected during these works and access to businesses and homes will be available at all times.

How this might affect you

To ensure the safety of the public and our staff, temporary changes will be in place on Kilburn High Road. A footway closure, pedestrian diversion, narrowed road and suspended parking/loading bays will be in place on Kilburn High Road. Additionally, the taxi rank outside of the Marriot Hotel will be maintained for drop off only.

What to expect

Footway closures and a narrowed road will be in place on Kilburn High Road

Pedestrian footway diversion route will clearly be signposted

Parking and loading bays will be suspended on Kilburn Priory

Noisy works will not commence before 10am

Continue to monitor our working methods to reduce disruption
