
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

In November we sent out a notification outlining works to take place within the A446 layby near Gorsey Lane, to create a permanent site access. These works will continue in 2023, from Monday 3 January 2023 and will continue until the end of January 2023. The construction of the site access will allow the delivery of plant and machinery into our works areas for the duration of our construction programme. The pedestrian walkway and cycle route currently in place will still be in use throughout the works.

Our working hours will be 8.00am – 6.00pm Monday to Friday and 8.00am – 1.00pm on Saturdays.
