High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI(BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

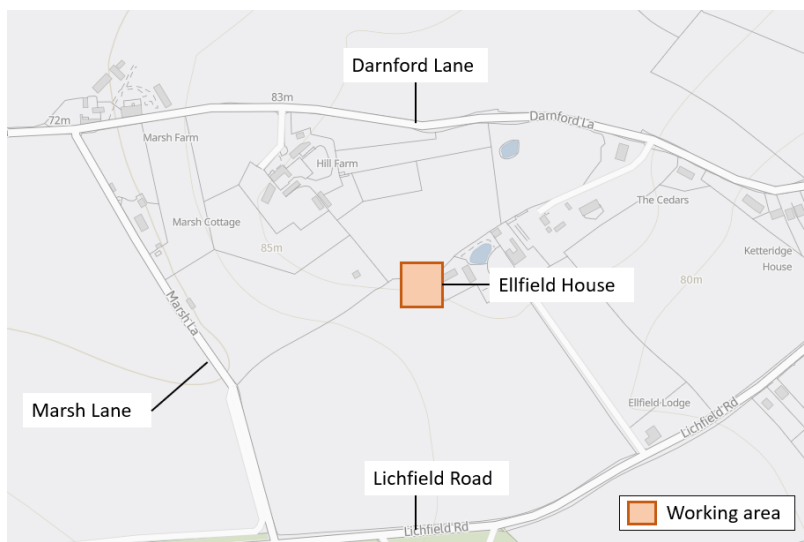
We will be starting works to dismantle a building at Ellfield House. To ensure that we keep the public safe we will install fencing and undertake vegetation clearance around the property, prior to commencing works.

## When the work will take place

The clearance and fencing works will take place from Monday 21 November 2022. Following these initial works, we will commence dismantling the building. This is estimated to take up to three weeks. Our working hours will be between 8am and 6pm (Mon-Fri) Our workforce can be on site one hour before and after to set up and secure our equipment.
