High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We are working on the construction of Marston Box which is the bridge that will carry the HS2 line across the M42 motorway between junctions 9 to 10. To enable us to complete these works we will extend our working hours at the Kingsbury compound site (subject to consents).

When the work will take place

We will extend our working hours from Monday 21 November to Friday 23 December 2022. We will be working 24-hour a day, over this period, to complete works to the structure of the bridge.
