



# Notice of traffic management on A543 Sutton Road and Drayton Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

We will be undertaking surveys and diverting underground utilities on the A453 Sutton Road and Drayton Lane. We will complete surveys to locate utilities in the highway and the verges at this location. Once we have completed our survey works, we will begin diverting the utilities ahead of the construction of the new railway.

These works will require us to excavate a section of the A453 Sutton Road and Drayton Lane. To ensure we can complete these works safely we will install temporary traffic management to manage the flow of traffic and ensure the safety of road users.

## When the work will take place

We will complete these works from 14 November 2022 until Friday 29 January 2023. We will install:

A lane closure with temporary traffic lights (24-hour a day) on:

- A453 Sutton Road / Drayton Lane – **15 November 2022 to 23 December 2022.**

A temporary closure (24 hours) on:

- Drayton Road – **09 January 2023 to 22 January 2023**

A lane closure with temporary traffic lights (24-hour a day) on:

- A453 Sutton Road / Drayton Lane **23 January 2023 to 29 January 2023.**

The traffic management will be removed over Christmas between 24 December 2022 to 08 January 2023.

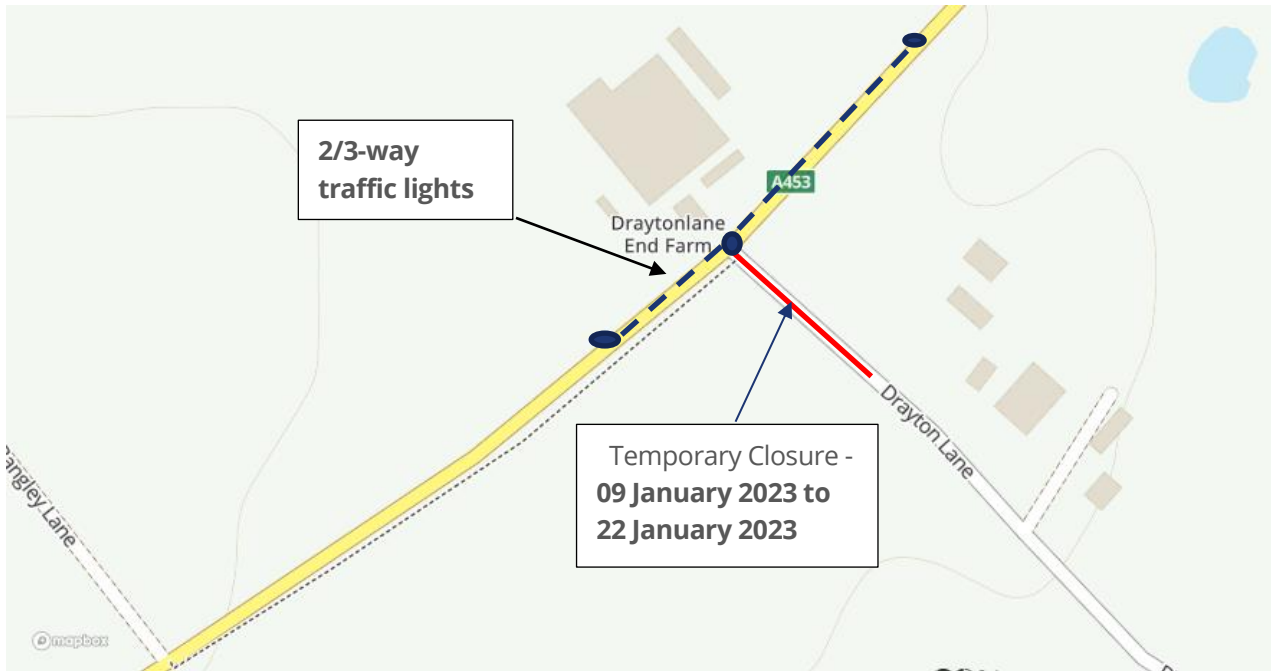
