Notice of UKPN Construction Works

High Speed Two (HS2) is the new high speed railway for Britain.

What are we doing?

In order to prepare for the future railway, UK Power Networks (UKPN) need to carry out electricity cable installation works within the Willesden Euro-terminal site.

UKPN will be undertaking a trial bore hole as part of the micro-tunnel feasibility works, to determine a fixed route for UKPN's cable route. They will then back fill their excavations and reinstate the area around to return it to its former state. All relevant consents/site access from associated stakeholders/landowners will have been obtained prior to the commencement of work.

UKPN will be working from Monday 21st November for 15 days.

How will this impact you?

UKPN will be working in the area highlighted on the map on page 2.

UKPN has a responsibility for delivering electricity services to homes and businesses across the region and will ensure that the impact of any work is kept to a minimum. There will be no impact to your electricity supply.

Works will be from the 21st November for 15 days.

Our core working hours are 8:00am to 6:00pm.

We will be on site one hour before and after the end of each shift

What to expect

If you are in the WET site, you will see a Heras fenced enclosure where our works will take place. You will see various plant and equipment to carry out the works and hear a generator hum and low level drilling noises if you are nearby within the site. Access in and around the site will not be affected.

We will complete the work as quickly as possible to avoid disruption and provide you access throughout.
