



Notice of environmental works to land north of Hall Lane, Swynnerton

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out early environmental works between the West Midlands and Crewe.

What we are doing

As part of our early environmental works, we will establish critical environmental and species relocation sites creating new habitats for local wildlife before any main work starts.

We will be creating various ecological habitats on land north of Hall Lane. The aim of creating these habitats is to provide time to establish before we need to undertake any follow up works.

The planting on this land will form part of the HS2 Green Corridor. The Green Corridor will run alongside the railway, creating a network of bigger, better-connected, climate-resilient habitats and new green spaces for people to enjoy – the Green Corridor is the largest single environmental project in the UK.

When the work will take place

We will start the work to create the habitats on 3 December 2022. This work will be ongoing throughout the year and the timeline for the works is shown below:

- Fencing – December '22
- Grassland creation – March '23 to April '23
- Hedge planting – September '23 to October '23
- Demobilisation – late-November '23

Throughout 2024 the habitats will be monitored and maintained, with regular visits to carry out tree and hedge cutting.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
