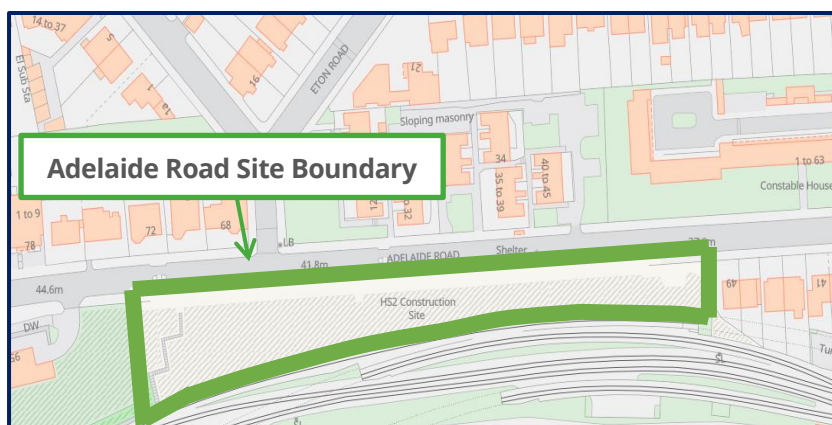
High Speed Two (HS2) is the new high speed railway for Britain.

## Utility works within the Adelaide Road Site

As part of the ongoing works within our Adelaide Road site, we would like to inform you of utility works within the site boundary.

From 7 November, for up to two weeks, works will take place to install a UK Power Network duct, and to install a Thames Water connection to supply water to the site.

This work will involve breaking concrete, and additional noise may be heard. Noise mitigation barriers will be in place, and we will continue to monitor noise levels.
