



Updated notice of temporary lane closures on Faraday Avenue

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be commencing works on the temporary diversion of Faraday Avenue. The temporary road will be constructed on land next to Faraday Avenue. To enable this work to be commenced, we will:

- Create a safe access point
- Construct a haul road
- Complete utility diversions
- Commence piling works

When these works will take place

These works will be completed in two phases.

During phase one, we will install a single lane closure on Faraday Avenue (Inbound), for two weeks, between:

- 9:30am to 3:30pm on Monday 14 November to Friday 25 November 2022 (Mon – Fri)

We will not install lane closures on the dates that were communicated in the previous notification.

The works that we need to complete for phase 2 are being reviewed and we will communicate these once they are confirmed.

Duration of works

The temporary diversion work will take place from late October until late Spring 2023.

Our working hours are 8.00am to 6.00pm and our workforce may be on site one hour before and after to set up and take down our work equipment.

Some low level noise will be generated from the work we are completing.

What we will do

Inform you in advance of any changes to the date(s) shown.

Keep all sites safe and secure.

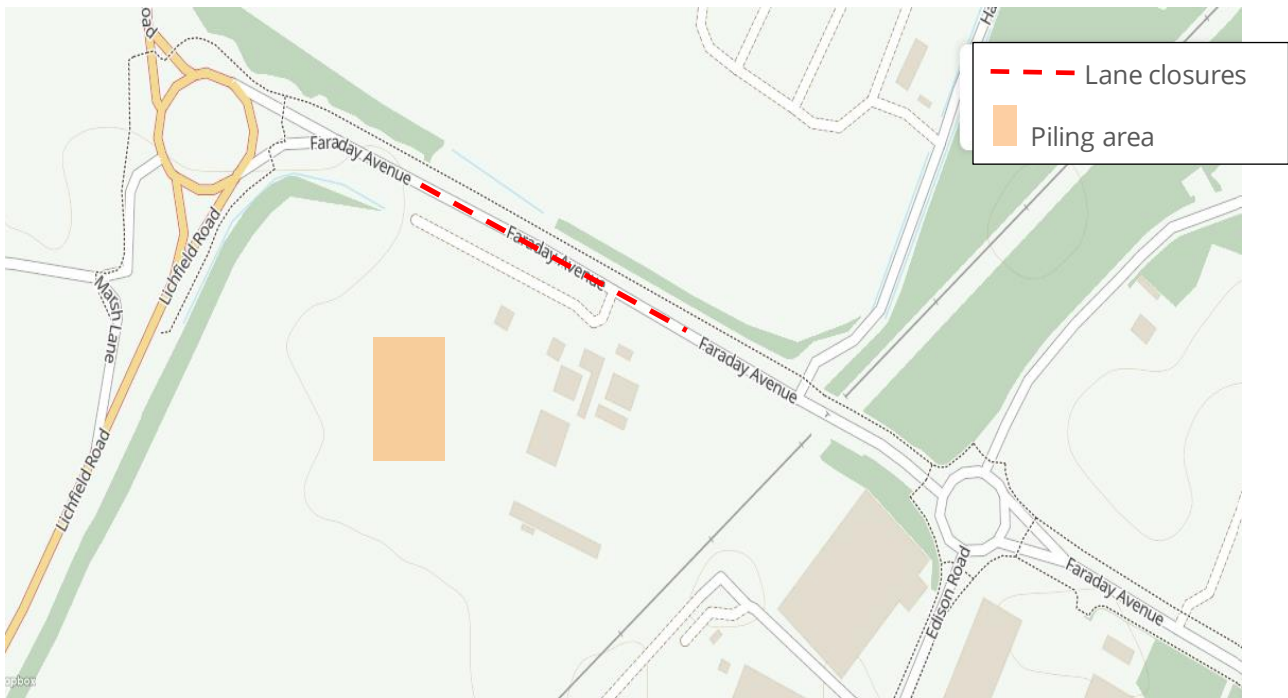
