



Updated notice of traffic management on A543 Sutton Road and Drayton Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We are diverting utilities on the A453 Sutton Road and Drayton Lane.

To complete these works safely we will require additional traffic management (traffic lights - 24-hour a day) on:

- A453 Sutton Road / Drayton Lane between **13 February to 24 February 2023**.

These works will require us to excavate a section of the A453 Sutton Road and Drayton Lane. To ensure we can complete these works safely we will install temporary traffic management to manage the flow of traffic and ensure the safety of road users.

When the work will take place

We will complete these works on Friday 24 February 2023. We will install:

A temporary closure (24 hours) on:

- Drayton Road – **9 January to 22 January 2023**

A lane closure with temporary three-way traffic lights (24-hour a day) on:

- A453 Sutton Road / Drayton Lane – **23 January to 10 February 2023**.

A lane closure with temporary three-way traffic lights (24-hour a day) on:

- A453 Sutton Road / Drayton Lane – **13 February to 24 February 2023**.

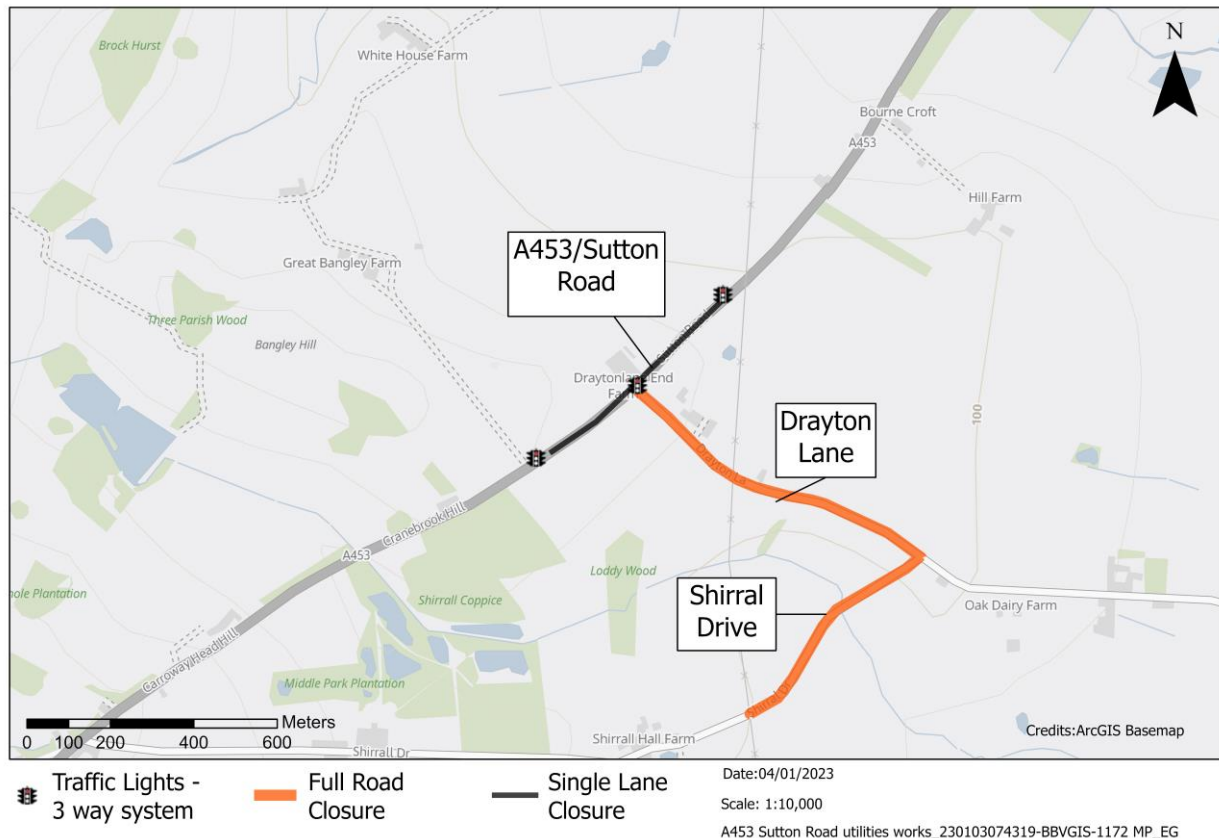
