High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be completing

We will be diverting additional utilities on the A429 Coventry Road between Kenilworth and Coventry. This is required in preparation for the future bridge structure and site access on the A429 at this location.

When will these works be taking place?

Monday 9 January 2023 to 24 February 2023 between 8am and 6pm. Temporary traffic lights will be in operation 24 hours per day on these dates.

To carry out this work safely, our contractor will require temporary traffic lights and will use vacuum excavation.

This work will be taking place outside of the BBV HS2 site on the A429 Coventry Road, Kenilworth. See map below for exact location.


