Notification

High Speed Two (HS2) is the new high speed railway for Britain. This is a notification to inform you of works requiring temporary traffic signals on B485 Chesham Road, Buckinghamshire.

What are we doing?

Two-way temporary traffic lights will be in place on Chesham Road, B485, to allow UK Power Network to work in the carriageway to safely complete the mains electrical connection for Chesham Road site. This connection will provide power to the HS2 railway in the Chiltern tunnel when it becomes operational.

How will this affect you?

Two-way traffic lights will be in place on Chesham Road:

From Monday 16 to Friday 20 January 2023

The traffic management will remain in place throughout this time. The connection is deep underground and will need to be excavated. Traffic management will operate and control traffic flows to ensure that operative can work safely in the carriageway during this time.

Has this closure been approved?

UK Power Network have obtained consent from the local consenting authority, Buckinghamshire Council, to carry out these works. A permit has been granted.

Additional information for residents living close to the works will be provided by UK Power Networks closer to the date of works.

Two-way temporary traffic lights remaining in place from Monday 16 to Friday 20 January 2023
